

H-D Insurance™ Sweepstakes Spending Spree  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

**PROMOTION DESCRIPTION:** The H-D Insurance™ Sweepstakes Spending Spree (“Sweepstakes”) begins on March 1, 2019 at 7:00 A.M. Central Time (“CT”) and ends 11:00 P.M. CT on August 31, 2019 (the “Sweepstakes Period”) and consists of six one-month periods (March 1, 2019 – March 31, 2019, April 1, 2019 – April 30, 2019, May 1, 2019 - May 31, 2019, June 1, 2019 – June 30, 2019; July 1, 2019 – July 31, 2019; August 1, 2019 – August 31, 2019) (each a “Monthly Promotion”; entry period for each Monthly Promotion is a “Monthly Promotion Period”). Each Monthly Promotion is a separate sweepstakes. Sentry Insurance a Mutual Company (“Sponsor”) is the sponsor of this Sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sweepstakes officials, which shall be final and binding in all respects and decisions. Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.

This may be done online at Insurance.Harley-Davidson.com, by phone at 800-909-8393, or by visiting a participating Harley-Davidson® dealership retail location. You may also enter by mail-in entry by sending your name, address, city, state, zip, and date of birth to: H-D Insurance™ Sweepstakes Spending Spree, Sentry Insurance, P.O. Box 8034, Stevens Point, WI 54481-8034. Mail in entries must include consumer contact information (email address and/or phone number) to be used for notifying potential winners, and be received by Sponsor by the first business day of the month following the Monthly Promotion Period in order to be eligible. If you properly complete one of these entry methods, you will then be entered into the current Monthly Promotion Period. Entries must be submitted during the applicable Monthly Promotion Period to be eligible for the prize awarded for such period. Limit one entry per person per Monthly Promotion Period, regardless of method of entry. Subsequent entries submitted by the same person/email/address in the same Monthly Promotion Period will be void. If you do not win in the Monthly Promotion Period, you may enter the Sweepstakes in the subsequent Monthly Promotion Period(s) by completing one of the methods of entry described above. Non-winning

**ENTRIES:** Entries that are mechanically reproduced, copied, illegible, incomplete, late or inaccurate are void. Incomplete entries not complying with these Official Rules are subject to disqualification and will be deemed void. Sponsor's entry decisions are final on all matters relating to this Sweepstakes. All materials submitted in connection with the Sweepstakes become the property of Sponsor and will not be returned. The Sweepstakes website's database clock will be the official timekeeping device for the Sweepstakes.

**WINNER SELECTION:** The potential winner of each Monthly Promotion will be selected in a random drawing from among all eligible entries received during the respective Monthly Promotion Period. The random drawing will be conducted on or about the end of the relevant Monthly Promotion by Sponsor or its designated representatives, whose decisions are final. There will be one winner chosen. The potential winner may be required to sign a certification of eligibility/liability release, applicable tax forms, and where legal, have the option to sign a publicity release, and return these documents to Sentry Insurance properly executed, within 7 days of issuance of notification or as otherwise directed by Sponsor in writing.
